Bylaws Review: Kathryn asked about the lack of Standard Operating Procedures. Gwen said that while we have no written SOPs, we do have a tremendous amount of institutional memory with the many past-presidents on the board. Dianne has pledged to make progress creating SOPs during her term as Chair-Elect. Jenny had some questions about the bylaws which she will communicate directly to Dianne.

Community Council Member and Board Roles: While Board Members represent an area by being aware of issues and providing a point of view, they are not a "representative" like the Legislature or City Council. By having board members from all neighborhoods, the whole board can represent the whole Avenues Community. That is why we are called "Greater." The primary task of the Board is to set the agendas for the Community Meetings. This is accomplished by paying attention to issues in neighborhoods and the entire Avenues' Community. Jurphy believes it is important to gather input from our neighbors. The GACC is a vehicle to discuss issues but the board does not take a position on issues. When the community decides to take a position, the board facilitates that process. The vote is always taken a month later at the next meeting after posting in the newsletter. The board then reports on the council vote.
