Fire Dept: A quiet month. In response to a question about the "new ATV" sutility in rescues the Captain responded positively.

GACC Budget Actuals: Michael Hughes (Treasurer) presented the actual summary of last year's income and expenditures, resulting in a net loss of \$8355. A question about LDS Hospitals contribution revealed that it goes direct to the printer, and is, therefore, not a line item for GACC.

Emergency Preparedness: Carleton DeTar describes the upcoming Emergency Preparedness Fair(with Ensign and Emigration LDS Stakes) at the Ensign School the afternoon of Sat, 22 April. It will focus on 96 hour Kits. Fire Dept and Salt Lake Emergency Management will be present, as well as vendors for kit components.

Indigenous Land Acknowledgement Statement: Hilary Jacobs Chair **motion** for adoption as stated carries with 34 Yay and 1 Nay.

Board Attendance: Jim Jenkin (Sec'y) Reports that his responsibilities include Board Member attendance. A role sheet will be available at GACC meetings and he will extract attendance from Zoom by screen names.

Street Fair: Daniel Gaffin described the Avenues Street Fair and asked for additional volunteers. He announced the change of Street Fair Chairs and introduced Daniel Sowards as new Chair. Merillee Morgan (Chair) called for volunteers for Co-Chair and other positions.

Ashley Anderson, School Board, described Superintendent Search. Questionnaire is on the GACC website for another week. School Closure procedure: Boundary realignment report expected in Feb. No changes this year or next.

Hannah Barton SLC Mayor's liaison: Will have outreach hours at the Sweet Library, 23 February, Noon to 2pm. NBA All-Star week: 17-19 Feb. Mayor's State of the City Address was last week and is available online.

Chris Wharton: Priorities: War Memorial renovation in Memory Grove; Trail system plan review; revamping landscaping ordinance; traffic calming and noise enforcement; increased fines for exceeding permitted construction; Cemetery funding from Legislature; replacing housing loss mitigation ordinance. Reports Affordable housing overlay pulled back to citizen committee - City Council to review soon. Clarifies homeless shelter possible locations. Mayor has allow County to use County facilities as emergency shelters - staffing is main bottleneck. Changes to ADU ordinance being considered. Supports owner occupancy and parking requirements.

Jen Plumb/ Todd Weiler:

J.P. has Newsletter available. School Vouchers and Transgender Bills broadly opposed by constituents. Priorities: Improve syringe handling possibilities; Creat Medical Director of DFS; ban solicitation for services in courtrooms.

T.W.: Lawyer working downtown and living in Woods Cross. Has weekly updates available by email. Has "Southdaviscommunity" Facebook Group available. Described Trans oriented bills.
