Chris Wharton: Changes to ADU ordinance being considered without owner occupancy requirement, which greatly concerns him. Asks for support for owner occupancy and parking requirements. City regulation of short term rentals is problematic and the repressive legislature will prohibit any success by the City. In order to effectively prohibit widespread ADU use as developed short term rentals and assure housing access for citizens he feels owner occupancy of ADU's is key. Feels ADU's can help with the ability to buy homes by providing an income stream. Height and massing requirements are present, and may be tweaked as the result of this review.
